# Group Carbon Reduction Policy

#### Introduction

Woodall Nicholson Group Ltd is committed to reducing its carbon footprint and achieving net zero greenhouse gas (GHG) emissions aligned to legislative and stakeholder climate targets.

As a specialist group manufacturing business, we recognize the importance of sustainability and environmental responsibility in our operations. This policy outlines our commitment, strategic approach, and the measures we will take to baseline our emissions, reduce them over time, and achieve net zero.

### Purpose

The purpose of this policy is to establish a framework for:

- Baseline Assessment: Accurately measuring and reporting our current carbon emissions.
- Emission Reduction: Implementing strategies to reduce carbon emissions across all aspects of our business.
- Net Zero Achievement: Ensuring that any residual emissions are balanced by equivalent carbon removal or offsetting measures by 2050 or sooner.

## Scope

This policy applies to all business units, employees, contractors, and stakeholders involved in the operations of Woodall Nicholson Group. It covers all aspects of our manufacturing processes, supply chain, energy usage, waste management, and transportation.

## **Objectives**

Baseline Carbon Emissions:

- Establish a detailed carbon emissions inventory as a baseline for future comparisons. Reduction Targets:
